Donna Austin, RySG:@Amr,: I think the purpose of the mapping would be to understand where and how the term is referenced or used.

Amr Elsadr:@Donna: Like I said..., I very much agree. Nora had asked if there are further actions we would recommend her department take. My point was that at this time, no. Mapping it out is plenty for now.

Jonathan Robinson:Queue closed on Item 6 after Phil Donna Austin, RySG:to be clear, I think it's very important that the process is finalised as the first step.

Mason Cole:Is the gist of the WG's pushback that the current model should be preserved vs. the model in rec. 23?

Amr Elsadr:I don't believe the terms of reference for this study was part of the scope of the working party.

Amr Elsadr:@Jen: +1. The role of the WP was a lot tighter scope-wise compared to a GNSO WG.

David Cake:I agree with Ed that there were some significant methodological issues

Amr Elsadr:@David: Yes, but that wasn't within the purview of the WP (as Jen mentioned).

Mary Wong: Westlake was engaged to be an independent examiner, which is one reason why they got to design the methodology. Also, note that the Board/OEC does not have to accept all of Westlake's recommendations (which is what they are, ie recommendations).

Philip Corwin BC/CSG 2:So is this a case of "garbage in, garbage out"?

Edward Morris: Thanks Mary and thanks Jen.

Edward Morris: Phil. Exactly.

Amr Elsadr:@Phil: "Garbage in" IMHO, yes..., "garbage out"..., I certainly hope so.:)

Philip Corwin BC/CSG 2:BTW, I have no idea why I am showing up twice in the attendee list, as I only logged in from one device.

Amr Elsadr:@Jonathan: I believe the council should support whatever response the WP comes up with.

Edward Morris: Recommendations are based upon bad data. This is supposed to be a scientific study not...let's come up with some ideas.

Stephanie Perrin: We certainly don't advocate wasting the considerable amount of money (although unknown) that was spent on this review.

Edward Morris:@Stephanie. I do.

Philip Corwin BC/CSG 2:On Rec. 23, want to note that BC has had no opportunity to discuss. But it seems suspect on procedural groaunds, being an enormous change at the last minute.

Edward Morris: A study based upon in competent methodology can not be relied upon. It should be completely disregarded.

Stephanie Perrin:Indeed Phil, that is the problem as far as I am concerned.

Philip Corwin BC/CSG 2:Agree with what Susan just said.

Amr Elsadr:So do I. @Susan: +1

Stephanie Perrin: You know I agree with you Ed, but if there are good ideas that came out of the public consultation it would be ok to salvage them.
