Coordinator: Thank you all for standing by. At this time I'd like inform all parties that today's

call is being recorded. If you have any objections you may disconnect. Thank

you, you may begin.

Terri Agnew:

Good morning, good afternoon and good evening. This is the Data and Metrics for Policy Making Working Group on the 4th of March 2014. On the call today we have Mikey O'Connor, Marinel Rosca, Cheryl Langdon-Orr, Tony Onorato, Pam Little, Andrew Merriam, Jonathan Zuck, Robb Shecter and Caleb Kow.

We have apologies from Abhijith Jayanthi. From staff we have Berry Cobb, Mary Wong and myself, Terri Agnew.

I'd like to remind all participants to please state your name before speaking for transcription purposes. Thank you so much and over to you, Mikey.

Mikey O'Connor: Thanks, Terri. I love the way you pause over your own name. And welcome, everybody. This is the first of many, I think, fun and interesting meetings about data and metrics for reporting.

> I see old friends and new people that I don't know on this call. And we'll spend some time sharing a little bit about ourselves in a minute.

There are several things that will happen at the beginning of every call. You heard Terri do the roll call and get the recording started. And these calls are recorded and archived for the world to see and hear. And another thing that we'll do at the very beginning of every call is check to see if anybody's Statement of Interest has changed.

Now on this particular call I wouldn't expect any because our Statements of Interest are all pretty new. But we'll always stop and ask for that. And if your status has changed, if you have a new job or you've changed roles, that's a good thing to let us know about.

And the other thing we'll do at the beginning of every call is take a moment to sort of run through the agenda and see if there are any things that we want to add or change about the agenda. And the agenda is in the upper right of the Adobe room.

If you're only the conference bridge and cannot get into the Adobe room, or as in the case of Cheryl Langdon-Orr, keep getting booted out of the Adobe room, and you want to speak, by all means, interrupt me. But otherwise raise your hand and Pam is showing off her hand-raising skills. And so I'll go to Pam next. Go ahead, Pam.

Pam Little:

Thanks, Mikey. I just want to give a update on my Statement of Interest. I tried to do that online but the drop down menu doesn't have a selection for Registry Stakeholder Group, only has Registrar Stakeholder Group. So previously when we were in the Chat or working group I was actually participating in my personal capacity.

But since then my employer, Zodiac, has become a member of the Registry Stakeholder Group. And I will be participating in this working group as a representative of the Registry Stakeholder Group. So if we could - if someone could let me know how to update that in my Statement of Interest online and also in this spreadsheet we have now shown on the screen. I just want to have the record corrected.

Mikey O'Connor: Thanks, Pam. Can I hand that action to you, Berry, for follow up?

Berry Cobb: Yes sure, Mikey. I'll take a look at it.

Mikey O'Connor: Thanks, man. And let me now demonstrate another feature of the Adobe room which is I'm going to do a round of applause for Pam's new status. That is great that you're going to be a Registry representative.

Okay I see that we've picked up a couple more people but I'm - was sort of hoping for a few more of the new ones. I think what I'm going to do is rearrange the agenda just a little bit. I would sort of like to wait on the introductions until we have a few more people on the call.

We may have shaken a fair number off because of that time change for the meeting; I'm not sure about that.

Cheryl Langdon-Orr: It was only 60 minutes.

Mikey O'Connor: Yeah, I know but you know how fragile these big meetings are, Cheryl.

Mikey O'Connor: So tell you what, let's skip Number 2 - and well, let me just pause for a minute. Does anybody have anything they want to add to the agenda besides the list that we've got here now?

One thing I think I want to highlight is that we are going to - is Number 6 which is we are scheduled to meet in a public session in Singapore. And so one of the very early things that we're going to have to produce is a set of slides to sort of introduce ourselves to that session. And going to kind of lean on Berry for a first draft of that as well if I can but that's just a thing to highlight.

And so I think what we'll do is head over to Item Number 3 which is the principles of transparency and openness. And, Berry, if you could just put up the section of the Working Group Guidelines.

While Berry is getting that on the screen for us let me introduce one notion.

We are going to run this working group as though it is a formal GNSO PDP working group but we are not. We are chartered as a non-PDP working group

and the reason we are is because our recommendations may produce policy

changes but they do they will have to launch a PDP.

These are more recommendations aimed at procedures and processes

perhaps the bylaws, etcetera. And so we're not running as a full PDP but

we're going to use the PDP guidelines, which is what Berry now has on the

screen. And that might be one to add to our background material for folks

who are new.

And the section that this is talking about is to say that pretty much everything

we do is public so our mailing list is publicly archived and visible to the

worldwide Internet; we record, we make audio recordings of these meetings

and I think in some cases when we really get going we may also record the

Adobe room. We share the Chat transcript. And, as you probably have all

found out, we're required to provide Statements of Interest.

And so this is just one of the things that we do at the beginning of every

working group and because we have a fairly large number of maybe first-time

working group participants I just wanted to spend a minute on that.

I think I've now killed enough time so I think what I'm going to do is roll back

to the Introductions agenda item. But just to give you a preview of the rest of

the meeting we're going to spend a few minutes introducing ourselves, letting

each other know a bit about who we are and what we bring to the working

group and what our interests are.

Cheryl Langdon-Orr: Mikey, Cheryl here.

Mikey O'Connor: Go ahead, Cheryl.

Cheryl Langdon-Orr: Having failed to make the Adobe room raise my hand, even though it was

attempting to, I just want to make an intervention that adds to what you were

just saying particularly the usefulness for people who have not done a huge

number of GNSO working groups before is the beginner's Webinars which I believe another one is running in the next few hours or day or so. So perhaps Berry could put in the details of that and send it out to the list for those who haven't attended the call. Thanks.

Mikey O'Connor: Yeah, that's a great reminder, Cheryl. And it's coming up soon.

Mikey O'Connor: There's an announcement. I bet Berry can find the link and put that in the

Chat. And welcome, Rudi, no worries.

Berry Cobb: Hi, Mikey. It's in the lower right corner.

Mikey O'Connor: Lower right corner.

Cheryl Langdon-Orr: And pushing...

Mikey O'Connor: Thanks, Andrew. One little note, somebody's not muted and...

Cheryl Langdon-Orr: It's me and I'm wearing a headset so there's no choice.

Mikey O'Connor: Ah, okay. Well...

Cheryl Langdon-Orr: That's my birdy background. I promise it will stop shortly.

Mikey O'Connor: Oh that's what that was. I was trying to figure out if that was breakfast dishes, a bird I wouldn't have come up with.

Mikey O'Connor: Yeah, this outdoor thing, it's a concept unknown to me; I haven't been outdoors in at least a decade.

Cheryl Langdon-Orr: All your birds would be frozen to death by now, Mikey.

Mikey O'Connor: That's true and probably shut me up too, which I will now do. (Caleb), go ahead. (Caleb) is typing. I imagine that's because he's got - we'll see what he's got to say anyway. For the transcript I'll read what you type, (Caleb).

And I'm very supportive of the work that this particular group has in front of it.

I also will confess to being one of the primary contributors to the - what ended

up to be the document which is the policy for the guidelines of PDPs in the

GNSO.

I contributed to a lot of what is now the guidelines we will be following. So I

tend to have a reputation of being somewhat queen of process so I might

bring us back to those agreed guidelines from time to time if we stray. Not

that people like Mikey would ever stray. And that's it for me.

Excepting I will link my page in the wonderful ICANN wiki world to my name,

at the moment the SOI is live, but the link to my personal page is not there. I

will remedy that unless Berry beats me to it. And on that page I maintain all

my updated affiliations and activities. Thank you.

Mikey O'Connor: Thanks, Cheryl. While you were talking you fell out of the Adobe room again.

Cheryl Langdon-Orr: Of course I did. Yes.

Mikey O'Connor: It's a feature.

Cheryl Langdon-Orr: I'm still trying to get back in and have been the whole time.

Mikey O'Connor: It's a feature. Well, there you go. You know, somebody else dropped out as

well. So I'm going to skip the next person and go to Janvier, is that how you

say your name?

Janvier Ngnoulaye: Yes, yes, is my name, yes Janvier.

Mikey O'Connor: Go ahead and tell us a little bit about yourself Janvier

Janvier Ngnoulaye: Okay thank you. So my name is Janvier. I hold a PhD in education technology. I'm currently a teacher in (ICT) at the University of Yaounde in Cameroon. I (unintelligible) one project formed by Internet Society impacts IPv6 in 2012 and 2013. Through the community grant program that consisted to educate and train the key people involved in the general development of Internet within the country.

So I'm currently the President of ISOC Cameroon chapter and also (unintelligible) member. So I understand very well the topic of the data and metrics in the Internet ecosystem.

So I - is my first time to join a working group - one working group at ICANN so I also hope that by joining Data and Metric for Policy Making Working Group I'll also learn and contribute so I dare to (unintelligible) since I don't have a very, very long (unintelligible) I hope to get more information from those who are there before working on data. So hope to also contribute - give my contribution so this is my (unintelligible). Thank you.

Mikey O'Connor: Thanks, Janvier. And let me extend a personal invitation to contact me directly if anything in this is confusing, the PDP process in the GNSO is a bit confusing. And do try to make that newcomer open house, that's the perfect place to learn a little bit more about this stuff so welcome.

Janvier Ngnoulaye: Okay thank you.

Mikey O'Connor: I think we need a pool on how many seconds Cheryl stays in the Chat room before she drops out. I think she lasted about 20 seconds that time.

Cheryl Langdon-Orr: You know, Mikey, Cheryl here. That could be one of the most useful

metrics we could collect on these calls, you know.

Mikey O'Connor: I think that, you know, that's the kind of stuff we're interested in. You know,

we're interested in data so anyway. Jonathan, carry on.

Jonathan Zuck: Hi. Jonathan Zuck. And I'm in the President of the Association for

Competitive Technology and we're an international trade association who represents mobile app developers. So based here in Brussels and we

represent about 5000 small and medium-sized businesses.

I've been engaged in the ICANN processes for, I don't know, maybe about 9

years I guess. And it just seems like 30. And worked on a number of different

working groups. Currently the chair of the other Metrics working group that's related to the new gTLD program and evaluating it in terms of consumer trust

and choice and competition.

And worked on the drafting team for this one. And those of you that know me

know that I bring up the topic of metrics with some frequency at ICANN

meetings so I'm very anxious and interested in the outcome of this discussion

because I think a greater use of data and metrics and defined success in

ICANN's activities is essential if they're to reach their goals of accountability.

Mikey O'Connor: Thanks, Jonathan. Next is another new name for me so if I mispronounce it

please correct me. I would say (Kaiute). Go ahead.

(Kaiode): Am I on?

Mikey O'Connor: Yes, I can hear you fine.

(Kaiode): Hello?

Mikey O'Connor: Can you hear me?

(Kaiode):

Okay so it's (Kaiode)but coyote is okay too. Okay so I'm Kaiode Su. I'm a young IT professional here in Nigeria. I have experience in networking, in telecommunications in security. I am interested in this working group - it's actually my first working group in ICANN. And I'm interested in (unintelligible) because it's about data metrics - I have interest in data gathering and data harvesting. And I believe this to be a lot of (unintelligible) for me so that's me. Thank you.

Mikey O'Connor: Terrific. Let me try it again, (Kaiode). Is that better?

(Kaiode): Good, that it. That's correct. That's it.

Mikey O'Connor: I bet it wasn't and you're very kind. Let's see, Marinel I'm going to go with.

Marinel Rosca: Yeah, hi. Can you hear me well?

Mikey O'Connor: Yes. Yes, can hear you fine.

Marinel Rosca: Hello, everybody. My name is Marinel Rosca. I'm based in Montreal in

Canada. I'm a first time participating to this GNSO. So before everything else

I'm here to learn a bit about this group. I have previous experience in

publishing some standards with the (3GPP) and (unintelligible) groups. I'm

from the mobility side of the road.

I'm interested - I've been part of policy management and policy creation before in this standardization groups and I'm as Internet and mobile are converging right now I'm here to understand a bit more about the policy management and a bit about this working group within ICANN.

And definitely I can help a lot on a analytics and data (mark) side of the policy creation, policy management of the experience, I have it and I'm a policy

provider. That help will be needed. So I'm very happy to get to know this groups and this working groups.

Mikey O'Connor: That's terrific. Just terrific. I'm going to skip - normally I'd call on Mary next because I've known Mary as a participant in the ICANN process but she's recently changed her hat and is now part of the staff so I'm going to skip her for a minute and go through the staff altogether. (Miguel), are you with us? You want to tell us a bit about yourself?

> If you're speaking we can't hear you. You may be on mute or your microphone may be muted. Oh (Miguel) is typing. Hang on a minute. I'm listening but I'm not hearing you yet. Try changing the mute on your microphone or if you're on the bridge I bet Terri can give you the secret code which I always forget which is how to unmute yourself.

> Oh, okay so we'll - this is one of the things that I kind of like to get through on the first call is that this Adobe room is a little puzzling. And so (Miguel), there's an icon - oh that sounds like possible movement. Do you want to try again? Yeah, go ahead. Still can't hear you unfortunately. I heard a little bit.

> So the icon is the one that is immediately to the right - I'm sorry, it's the second one to the right of the audio word at the very top. Yeah and Mary is suggesting the little telephone handset icon. Oh that was promising. That's a weird symbol; I've never seen that before. It looks like you're connected but I don't know what that red - that red sound that came out meant. Any Adobe old hands that can clue us in on that one?

> (Miguel) is going to switch to headphones which seems like a - I have to fiddle with it a good bit. In fact I sort of gave up using my computer and went back to using the phone because I couldn't get the microphone really to work correctly. And that's a - oh this is promising. (Miguel), you want to try again?

It's possible - I'll give it just a - oh, yeah, Rudi's chiming in saying the audio connection - it's quite variable. Some of us have good luck and some of us don't. I have random luck and it's always - it always seems to me that when I'm leading a call is when things don't work very well.

So, (Miguel), what do you think? You want to try again or shall we - if you would like I could stay on after the call is done and we could sort out the connection or Terri has just suggested that we could also dial you if you want to just put your phone number in there, we could call you. That would be another way that you could join.

I think that's what we'll - we'll leave it at that for now and, (Miguel), I'm really sorry that this didn't work. Know that you are not alone. (Miguel) has got his phone number in there so I tell you what Terri completes the dial out we'll circle back to you, (Miguel).

And with that onto Pam. Pam, you want to...

Pam Little: Yes, can you hear me?

Mikey O'Connor: Yeah, can hear you just fine.

Pam Little: Okay. Hi everybody. I firstly like to welcome Andrew Merriam, my colleague from the Registry Stakeholder Group. And it is really wonderful to see him

joining this working group and supporting me.

I realize how difficult it is, everyone, in terms of time zone and work load. And I'm also very pleased to see on the list we seem to have quite a few new registry operators representative joining this working group. And in the Asia-Pacific region as well, I can see someone from China, someone from Singapore and that's really wonderful to see as a new member or new participants in the ICANN community.

I used to work for ICANN for a number of years out of the Sydney office until about the end of 2012, then ICANN decided to close that office so I subsequently worked for - have been working for a group that applied for a number of new gTLDs.

And also become members - or been delegated so become members of the Registry Stakeholder Group. And therefore, as I said earlier, I'm now joining this group as a representative from the Registry Stakeholder Group, same as Andrew. And I can see a number of others as well so that's really good. I look forward to working with everybody on this group.

Mikey O'Connor: Thanks, Pam. I'm going to give a little advertisement that you skipped and that is that Pam was a member of the Compliance team and thus is really good at data and metrics from that perspective. It's great to have you...

Pam Little:

Thank you, Mikey.

Mikey O'Connor:in the group. Robb, go ahead. We're not hearing you either, Robb. You may need to fiddle with the microphone or phone muting depending on how you're coming in. Still not coming in. Yeah, you and I are in the same boat, Robb. This is why I switched back to going in on the phone is that...

Cheryl Langdon-Orr: I always do both.

Mikey O'Connor: ...yeah, I just - there were days when it worked and there were days when it didn't and I could never quite get the chicken entrails in the right place to make the Mac talk to Adobe and so I finally switched back to good old telephone. So you're not alone, Robb, believe me. And I'm sorry that it's not working real well.

> It's great when it works and it's terrible when it doesn't. What can I say? Oh, (Miguel)'s on the phone. (Miguel), you want to try again?

(Miguel): Hello, you listen to me now?

Mikey O'Connor: Oh it's lovely. It's perfect.

(Miguel Rassil): Okay, okay that's good. Sorry for the (unintelligible) I don't understand why

my connection is working now because it worked two hours ago and well. Let

me introduce myself, my name is (Miguel Rassil). I'm from Spain but I'm

working in Brussels. You are right, I am working also here in Brussels around the Commission. And I'm working in the public sector. That's my interest of

this group is that was the first one because it's related to the - somehow to

the policy sector and also to the metrics for the legislation broadly.

And the second thing is because I'm also doing a doctorate related to mechanisms to extract data from the (program) to have knowledge. And I think I can contribute in both things (unintelligible) knowledge on public sector and maybe can be applicable here. And the second (unintelligible) my

doctorate.

Mikey O'Connor: That's terrific. This is going to be a pretty high power team, I can tell. Thanks,

(Miguel) and thanks for your patience with our audio. And it looks like we're

offering Robb the same option. You know, I wish we could make this work but

it's good to find this out on this sort of light-duty call rather than heavy-duty

stuff.

Rudi, go ahead.

Rudi Vansnick: Hello, everybody. My name is Rudi Vansnick. I have 35 years in (ITT), 20

years in Internet and especially in Internet Society I'm celebrating this year

my 20 years membership. I'm also of the Board of Trustee of ISOC.

In ICANN I started in 2005 together with a lot of people in the At Large. We

created the At Large Advisory Committee and I'm - I enjoyed the time that

Cheryl was chairing the At Large. It was an amazing period.

And after my eight years in At Large I stepped over last year into the policy work. I'm now the Policy Committee Chair for the NPOC. I'm also working closely together with Jonathan on the Implementation Advisory Group on Customer Trust and Customer Competition. In that working group we are going to do a lot on metrics and that's one of the reasons why I wanted to join this group also.

I can always learn a lot more. You can never know enough in the ICANN world as ICANN doesn't know itself how good it is.

Mikey O'Connor: Here here. And I'll also add a here here to the amazing period when Cheryl was the Chair of the At Large; that was an amazing period. Thanks, Rudi. Tony, you're last and then I'm going to let the staff introduce themselves too because it seems only fair, they're pretty high powered bunch as well. Tony.

Tony Onorato:

Sure. Thanks, Mikey. Tony Onorato for the record. I am lawyer in New York and I was involved with the Metrics and Reporting Team that worked up the draft charter for this group. That was a very interesting process and really engaging process and it was naturally quite enjoyable to segue that into the working group.

I'm also involved with some of the others here on the IAGCCT Consumer Trust and Competition group that's also dealing with metrics and what metrics and how to obtain them, how to handle them, how to fashion those requests, all those good things around metrics.

So at bottom I have a burning passion for metrics I guess. And this seems like a natural home for me. But seriously it's quite enjoyable. I really look forward to the work on this. And I think the coordination between the various entities within ICANN that are looking at these metrics issues is particularly important for the policy development over the next at least year and going forward. So anyway I look forward.

Mikey O'Connor: Thanks, Tony. Tony was a big contributor to the drafting of the charter. Okay, Berry, you want to lead off the staff team? You're our transitional guy from participant to staff along with Mary.

Berry Cobb:

Yes, thank you Mikey. This is Berry Cobb. As Mikey just mentioned, way back in the day I was - participated on the original Registration Abuse Policies Working Group. I believe at the time I was a member of the Business Constituency.

Since then I have kind of semi-converted over. I help contract with the GNSO Policy team on various duties, some of which is to assist with some of the working group calls as to which we're on now.

Like many on the group I do have a lot of similar metrics and reporting background predominantly back in my day working with IBM we would be involved in large-scale service delivery contracts. And we would need to produce reports that would show our delivery performance against those contracts as well.

So it involved a lot of metrics that would be basically rolled up across multiple delivery sections within an overall outsourcing agreement that involved a lot of big data and of course I think the primary component to those metrics was to develop them in a way that were meaningful and actionable.

And certainly when we were in the throes of the RAPWG back in the day, as well as some other working groups, you know, we recognized early on that we were basically operating in a vacuum in terms of having access to certain kinds of data to make better decisions or fact-based decisions on our policy efforts.

So that's kind of the essence of why this group is here. And so glad to be here and help the team. And look forward to working with everyone. Thank you.

Mikey O'Connor: Thanks, Berry. Terri, go ahead. Tell us a little about yourself.

Terri Agnew: Hi, my name is Terri Agnew and I'm a GNSO Secretariat so I work behind the

scenes and send out email invitations and reminders.

Mikey O'Connor: So somebody's got to mute their speaker...

Mikey O'Connor: ...echo. So that's another hygiene thing with the Adobe room is that echo that

you're hearing right now is because somebody's speaker on their compute is

turned on.

Cheryl Langdon-Orr: Deafening.

Mikey O'Connor: Yeah. Poor Terri. Not only does she get interrupted but she gets interrupted

by a call quality problem. There we go, yes...

Mikey O'Connor: ...mute your mics and speakers. Yeah, it's just, you know, it's the fickle finger

of fate. Okay it seems to have stopped. Terri, back to you.

Terri Agnew: Oh, I had finished my explanation.

Mikey O'Connor: Okay. Well thanks. Terri is - and the rest of the GNSO Secretariat is an

amazing group of people that, for those of you who don't know, and haven't worked in the GNSO before, you will come to appreciate is the reason the

GNSO works so thanks for being with us, Terri.

Mary, I think you're last on my list unless there's somebody that's (unintelligible). Go ahead.

Mary Wong: Okay. I don't know if you guys can hear me because I'm actually on the

Adobe audio. Is this okay?

Mikey O'Connor: Yes, it works fine.

Mary Wong: Great. So, hi everybody. As Mikey said I was a former member - I am a

former member of the ICANN community. My name is Mary Wong. And I was on the GNSO Council before Mikey was on, although it was a pleasure to work with Mikey in his various roles there. And then I was also on the ccNSO

I've had the pleasure of working with a lot of folks on this working group in various capacities. And it's particularly nice to see so many newcomers as well as people from different parts of the world.

I've been a member of ICANN staff for maybe six months or so and I look forward to working with all of you. I primarily support the GNSO which includes all of you.

Mikey O'Connor: Thanks, Mary. And Robb is now with us on the phone so we'll go to Robb.

Robb Shecter: Yeah.

Mikey O'Connor: There you go.

Robb Shecter: Is this working?

Mikey O'Connor: It is working.

Cheryl Langdon-Orr: Yeah.

Robb Shecter: Okay great. I'm a lawyer and a software engineer in Portland Oregon USA.

And I basically have a couple of startups that I'm a founder of or a cofounder.

And I do a lot of work in government transparency reformatting - making the law more accessible. I also do work with wikis and helping scale wikis up and hoping to work with the new dotWiki top level domain that's coming up soon.

And one of my real interests is research methodology and using data wells. And so the whole nature of this group and the policies that it's looking at are just really interesting to me. And I can see that having good data and a policy around how we report is just - is really important to my foundation to have better policy come out in the future.

Mikey O'Connor: This is great. Where have you been all my life? I'm glad we got you in there,

Robb.

Robb Shecter: Thanks. Yeah, you know, this is my first working group. I'm really excited to

get involved here with the GNSO and with ICANN. I've done a lot of work with Internet standards over time, done a lot of software development, you know, having to, you know, read through and understand every RFC out there it

feels like sometimes and so I'm really happy to get involved in making the

sausage, you know?

Mikey O'Connor: Yeah. Well it's great to have you. In fact, it's great to have you all. Now,

before I wrap this part up is there anybody that didn't get a chance to introduce themselves? You know, there may be people that are just on the

phone and I'll just take a moment to see if anybody wants to shout out and

say, "Wait, what about me?"

Okay, we've got I think enough time to take the next agenda item, which is

Number 4. And Berry, who's got extra sensory perception is way ahead of me

and has the description of what the chair of a working group does. This is

also from the GNSO Working Group Guidelines. And...

Cheryl Langdon-Orr: Yeah.

Mikey O'Connor: ...so this is something - one of the things that we will do as much as we possibly can - Berry and I talked a little bit about this before the meeting - is we will try to have things on the screen that you can read in addition to talking because I know that some of you are more comfortable with written English than spoken English and this is one of those things.

> The way this goes is - and I'm going to read the little phrase there because that's also out of the Working Group Guidelines is normally a chair will be selected at the first meeting of the working group. This is that meeting.

The working group can elect to have more than one chair, co-chairs, vice chairs, all sorts of options there. And once we select a chair or co-chairs the GNSO Council confirms that selection. Never in my living memory has the Council not approved a chair selection but I suppose there's always a first time.

And so this is the time for people who would like to take on a role like that to make their intentions known. I will let you know that I would be willing to cochair if that shows you all anything. And I got a tick mark from Cheryl, that's great.

Anybody else interested in doing the chairing stuff? Don't all leap up and speak at the same time.

Cheryl Langdon-Orr: Mikey, Cheryl here. I just wondered...

Mikey O'Connor: Go ahead, Cheryl.

Cheryl Langdon-Orr: ...if this is a particular situation - now I know it's a non-PDP working group but we also have agreed to work with the GNSO Work Group Guidelines. And there are particular roles in that guideline for the liaison role, which you

already have if in fact we came to some impasse or issue. And whilst that doesn't conflict the chair there are times when if one route failed the other is

set there as sort of a built up braces approach.

I wondered if this might be an ideal circumstance to go for a co-chair so that, you know, there's never a - which hat do you wear question, there's always someone else to put a hat on. So I was just going to pose - whilst you have my absolute endorsement to continue herding the cats, as you do so well, I

wondered whether this may be an idea group to have a co-chair relationship.

And if that's the case perhaps you - if you don't get a taker here we should go to the larger list as well so, say, you know, appoint you as chair and seek a

co-chair if need be. Thanks.

Mikey O'Connor: Thanks, Cheryl. I had another idea in addition to that which was that if I was

the chair we have other members of the Council on the group and I might ask

one of them to take over the liaison job.

Cheryl Langdon-Orr: Good way out of it as well, yeah.

Mikey O'Connor: Yeah. But I think one of the things that a co-chair does is gives us a chance

to bring new people into the leadership circle.

Cheryl Langdon-Orr: Yeah.

Mikey O'Connor: And one of the things that I've - many of you have heard me comment is that

we're pretty thin in the leadership group in the GNSO especially in the

working group chair group. So if somebody wanted to take on a co-chair role

for that reason as well...

Cheryl Langdon-Orr: Training wheels.

Mikey O'Connor: Training wheels, yeah. I mean, my mentor in this was Roberto Gaetano, many of you know Roberto from the - either the At Large or from the Board. And it was really, really helpful for me to be the junior co-chair of that pretty

lively working group.

Rudi, you're right, I was really lucky and it was a wonderful experience to work with Roberto. So I would be more than happy to entertain the possibility of somebody joining as a co-chair on this group. I'm not sure I can live up to

Roberto's standards but I would certainly try.

The other thing is that it's - I think, Cheryl, you're right, we don't have the whole group, by any means, on this call. We probably never will. But I'm perfectly comfortable putting this to the list and letting it...

Cheryl Langdon-Orr: Percolate.

Mikey O'Connor: Percolate, yeah, cook on the list for a week or two or three even because...

Cheryl Langdon-Orr: Yeah.

Mikey O'Connor: ...you know, we've got amazing continuity. We have a lot of people who were on the drafting team and so it's not as though we need desperately to have this issue resolved now. And given that we're very close to the top of the hour I think that's the thing we need to do.

> Robb, are you volunteering for co-chair with your interested in learning comment? Because if you are that would be terrific. And...

Cheryl Langdon-Orr: Sounds like a plan then, Robb.

Robb Shecter: Thanks.

Mikey O'Connor: We're off to a good start. Now that does not mean that we stop at that; we could have more because this group, as you'll see - I think at the next meeting we'll pick this agenda up right where we left off, maybe introduce a few more people. (Gabriel), I think we'll let you introduce yourself on the next call because we are sort of running out of time but it's great to have you on and we'll look forward to hearing from you next time around.

And as you take a look at our charter you're going to see that we have a lot of work to do. And we may very well want to break into some parallel tracks for a while or some sort of divide and conquer for this work. And so we, I think, could use a fair number of leaders in this working group. And with that I think we'll leave that topic for today.

And the one that I really want to touch on before we break up is if you haven't already please take a very, very careful look at the charter because there's a lot of really good material in there that lays out the framework of what we're going to do. And don't just read it, start thinking up your answers to those questions on a very preliminary basis.

I think one of the exercises that we may want to go through is for all of us to write down some preliminary answers to the questions in our charter just as a starting point. And so when you read it jot down some notes and I'll try to figure out what we're going to do with that information at the next call.

A final thing, always, is right here at the top of the hour is to confirm that we will meet at this very same time in a week. And so we look forward to seeing

you all. And with that I think we'll close this call off. I think we're off to a great

start. Thanks all for joining, see you in a week.
