The General Assembly, recognized as the highest level of deliberation within the organizational structure, will be composed mostly by "Affiliate" members being they natural persons - representatives or not, of different instances social and/or civil regardless of the sector to which belong - who in odd number not exceeding 15 undergo discussion resolving by a majority of two-thirds (66%), all those matters that to their knowledge be submitted. The outcome of such discussions will be reflected in "recommendations" which nature will be mandatory since they do not rely on the judicial intervention of the Board of Directors (event in which will take the name of "observations" hold binding force unless there is the final decision in this last instance) except that it declares itself unable to decide on that issue in particular.

Article 5

- 2. The Organization shall have in principle and without prejudice to future amendments that might take place, the following distribution or organizational composition:
- 3. General Assembly

4. Board of Directors

- 5. <u>Management:</u> General, Administrative and Financial, Scientific and Commercial and Operational.
- 6. Directions: Internal control.
- 7. Such structure will be divided into three (3) large levels without having a rigid hierarchy between them. Also the issues dealt with, will be classified as "significant or substantive" and "procedural or routine" without prejudice to coexist mutual or functionally in all units. Article 8 The General Assembly will hold meetings on a regular basis at least twice a year in half-yearly intervals, being able to meet in an extraordinary way at any time at the request of the General management. **Paragraph**: meetings of the General Assembly will be held with the presence of all its members - except for just cause or force majeure where an odd number not less than nine (9) will be enough - and, the Executive Assistant Manager whose assistance will ensure balance in the decision-making process due to any controversy or numeric missing that about the quorum could arise by conferring to him the ability to vote, exclusively for such circumstance. Meetings will be chaired by the President of the General Assembly and a Secretary (role, except for absence of the latter or determination against, may also be held by the Executive Assistant Manager), at the same time, being both responsible to subscribe the "Acts of Commitment" that take place in the respective meeting.

8. Article 9

9. The Board of Directors is integrated for life by the persons who signed the Constitution Act as founders or "partners", also being the highest body within the organizational structure management and decision-making. Its determinations reflected in "resolutions" (binding at any time or place), will be result of an internal vote by simple majority (51%) shall decide on any kind of issue to be aware. Four (4) of its members will have permanent seat in the General Assembly (with voice - non-voting - right) and can play not only the duties expected and inherent in such positions but also, the legal representation provided this is required. The designation to take place due to situations of partial or total absence of the Legal representative or Senior Manager shall be governed pursuant to article 7, paragraph C. to preserve the operational normality within and outside the Association.

10. Article 11

a. The Board of Directors will hold meetings once a year, ordinarily (during the first four months) in the main headquarters of the Association and, in an extraordinary way, as agreed by its members, or convened by the General management. **Paragraph**: the Board of Directors will meet with the presence of all its members - except for just cause or force majeure, where an odd number not less than five (5) will be enough - and that of the Legal representative or Senior Manager whose assistance will ensure balance in the decision-making process due to any controversy or numeric missing that about quorum could arise by conferring to him the possibility of voting exclusively for such circumstance. Meetings will be chaired by the President of the Board of Directors and a Secretary (role, except for absence of the latter or determination against, may also be held by the Legal representative or Senior Manager), at the same time, being both responsible to subscribe the "Acts of Commitment" that take place in the respective meeting.
