Applications Received






- Total number of applications: 1930
- Applications for contested strings: 751
- Applications for internationalized domain names: 116
- Applications designated by applicant as community-based: 84
- Applications designated by applicant as geographic names: 66
- Financial support applications: 3

Application Subsets








Applications per Region







Customer Service Center





- Over 9000 inquiries received to date
- Performing administrative completeness check
- Processing refund requests
- Processing change requests
- Developing regional locations

TAS





- Taken offline 12 April
- Brought back online 21 May
- At the time of take down:
 - 1268 registered users
 - ~95,000 file attachments
 - 2091 applications submitted or in progress
 - ~455 instances where file name / user name might have been viewed by another applicant.
- Affected users informed
- Majority of users unaffected

Addressing the Glitch





- Goal was to handle with maximum transparency: web updates, CSO video, FAQ
- Affected applicants notified on 8 May
- Offered a full refund of fees paid
- Took steps to improve system performance to account for increased demand on the system

Evaluation Process


Timelines





- Initial evaluation begins 12 Jul
- Schedule:
 - Batches in 5 months each or
 - One batch in 15 months
 - Early projection: all applications in 15 months
- Objection period: 7 months for all applications
- Comments in first 60 days sent to evaluators

Objections & Dispute Resolution





- MOUs executed with dispute resolution service providers
 - ICC (Paris)

 - ICDR (New York)
- Independent objector: Prof. Alain Pellet
- Auctions: Power Auctions

Support Applicant Review Panel (SARP)





- 80 applications from 47 countries
 - 18 Africa 11 Europe
 - 23 Asia Pacific
 17 North America
 - 11 Latin America/Caribbean
- Diversity in experience: operating in developing countries, domain name industry, public interest, small business, registry management, financial expertise, awarding grants
- Five-member panel to be convened

- Aug Sep 2012
 SARP Evaluates Support Applications
- Oct 2012Notice of results

Batching Goals





- Effective administration

- Consistency and quality across evaluations

Rights Protection Mechanisms





- Trademark Clearinghouse
 - Selection of service providers
 - Development of draft implementation model
 - Refinement of requirements
- URS
 - Seeking feedback on whether/how cost targets can be met

Second Application Round Planning





- Board reaffirmed ICANN's commitment to opening a second round of applications in the New gTLD Program as expeditiously as possible.
- Meet commitments re: first round
 - Processing of applications
 - Addressing GAC recommendations for assessment of TM protection, root zone operation
- Generate prerequisites to inform planning
