Background

- GAC-GNSO Consultation Group (CG)
- To address GAC early engagement in GNSO Policy Development Process (PDP)
- Early engagement identified by both Accountability and Transparency Review Teams (ATRT1 Rec. 12, ATRT2 Rec. 10.2)
- Group commenced work Q1 2014
- Two work track
 - Day-to-day co-ordination
 - With PDP



Work Track I (Team 1)

- Mechanisms for day-to-day ongoing cooperation
- Six potential opportunities identified
 - A. GNSO Liaison(s) to the GAC
 - B. GAC Chairs / GNSO Chairs regular interaction
 - C. Topic Leads / Buddy System
 - D. Rethinking recurring joint meetings / conference calls
 - E. Further develop early awareness & notifications
 - F. Utilize existing GNSO Council PDP liaisons in interactions with the GAC
- Refined initial focus on options A + F & E

Description (TBC)

- GNSO Liaison to the GAC
- Appointed by the GNSO Council
- Likely Outgoing Councilor or recently stepped down
- Implemented as a pilot
- Evaluated after one year
- Travel funding agreed for FY15 (i.e. starting ICANN 51)



Responsibilities (TBC)

- Attend and participate in GAC meetings
- Represent and communicate GNSO policy work
- Work closely with GNSO Chair and Vice Chairs
- Liaise with ICANN policy staff in the preparation of briefing materials and/or responses to questions
- Liaise with relevant working groups, utilizing GNSO Council liaisons where required
- Provide regular updates to the GNSO Council
- Guide the GAC in opportunities for early engagement
- Keep the GAC updated on how its early input was considered by the GNSO
- Assist in facilitating GAC-GNSO discussions in cases where GAC early input is in conflict with GNSO views



Practical Working (TBC)

•Attend all GAC open meetings, be allowed to request floor

•Attend GAC closed meetings when discussing GNSO related topics and be allowed to request the floor

•Attend GAC conference calls by invitation and accordingly be allowed to request the floor

•Join GAC WGs by invitation and accordingly be allowed to request the floor

•Not on GAC mailing list but may send to it through the mailing list admin and receive replies by being cc'd



Action 1 for ICANN50

Seek to obtain GAC and GNSO

- Approval to proceed with this option starting ICANN51 / LA meeting
- Approval of <u>detailed specification</u> including appointment and removal mechanism



F. GNSO Council PDP Liaisons

Description

- Group of existing GNSO PDP Liaisons
- Typically participate in GNSO WG deliberations
- Experts in the different GNSO ongoing policy activities
- Have a seat on the GNSO Council
- Will support the GNSO Liaison to the GAC
- In case specialist knowledge is required, may interact directly with the GAC when necessary / desirable



F. GNSO Council PDP Liaisons

In practice?

- A mailing list of GNSO Council PDP WG liaisons could be created to flag certain items that should be brought to the attention of the GAC
- Regular calls could be scheduled between the GNSO Council PDP WG liaisons and the GNSO liaison to the GAC



F. GNSO Council PDP Liaisons

Action 2 for ICANN50

Seek to obtain GAC and GNSO

Conditional (on Action 1) support to move ahead with this as it provides support for the GNSO Liaison to the GAC



E. Early Awareness/Notifications

- Notifications currently sent by GNSO Secretariat to GAC Secretariat and/or GAC Chair
- Documents then posted on the GAC website and GAC members notified
- Notifications may be (often?) lost in the multitude of emails GAC members receive
- Alternatives explored to go beyond a simple "heads up"
- Further feedback / input from the GAC is desirable in order to expand on this option



E. Early Awareness / Notifications

- On-line <u>survey</u> for GAC members input deadline 12 July
- Objectives of survey:
 - Inform GAC members of existing opportunities to engage in GNSO PDP
 - Understand GAC member views on timeliness and overall utility of existing mechanisms whilst aiming to develop improvements
- Early Awareness / notifications to be further reviewed following results of survey

Action 3 for ICANN50

Participation in the survey from GAC members in order to best inform the work of the Consultation Group

Work Track II (Team 2)


- GAC early engagement in GNSO PDP
- Look at 6 phases of the current GNSO PDP
 - 1. Issue Scoping
 - 2. Initiation
 - 3. Working Group
 - 4. Council Deliberations
 - 5. Board Vote
 - 6. Implementation
- Initial focus on early phases 1 & 2



Objective

- Ensure GAC is aware of all existing mechanisms available to provide input into the GNSO PDP
- Enable GAC to provide input in a timely / meaningful way
- If / when GAC decides to provide input, have a common understanding of what the potential impact of such input is (e.g. on the PDP timeline as well as WG/Council response)
- Develop a manageable and sustainable mechanism taking into account number of ongoing PDPs as well as desire for effective and timely policy development


GNSO PDP Phases Diagram

Current focus

- Includes request for / publication of preliminary Issue Report for public comment and

- GNSO Council consideration of whether to initiate a PDP and development of PDP Charter



Phase 1: Issue Scoping

Existing Engagement Opportunities

- <u>Any</u> Advisory Committee can request an Issue Report (in addition to Board or GNSO Council)
- Preliminary Issue Report (drafted by Staff) published for public comment for at least 30 days
- Summary Report produced following public comment
- Final Issue Report submitted to the GNSO Council (usually within 30 days after close of public comment forum)



Existing Engagement Opportunities:

- If PDP not initiated on issue requested by AC)
 Option is to request reconsideration (not used to date)
- Initiation by GNSO Council; consideration usually at first meeting after submission of Final Issue Report
- Charter <u>If</u> Drafting Team is formed to develop charter for the PDP WG, call for volunteers (open to anyone)



Ideas being explored

- Review outcome of survey to establish whether early PDP engagement communications are known / work
- GAC 'Quick look' mechanism; establish whether issue has potential public policy implications, flag as such at early stage
- Additional support to allow GAC to provide timely input
- Ensure that any GAC positions / advice are included in the Preliminary Issue Report
- GAC could consider creation of Triage committee



Looking ahead

- Consultation Group to review input received in London
- Implement pilot project for the Liaison (if approved by GNSO and GAC)
- Review survey results
- Further develop recommendations for review, discussion and possible conclusion at the ICANN51 in Los Angeles
