## Background of the JIG

- Charter adopted by both the ccNSO and GNSO Councils:

- The purpose of the JIG is to identify and explore issues and topics of common interest of relevance to both the ccNSO and GNSO and report on such an identified issues to the respective Councils and propose methodologies to address the issues

## Proposed Recommendations

- A. Requirement for IDN TLD operators to support Universal Acceptance of IDN TLDs in their own systems
- **B. Allocate specific budget for the advocacy** of Universal Acceptance beyond the passive development of informational materials and toolkits
- C. Development of checklist/guides for new IDN TLDs to handle issues of Universal Acceptance
- D. Direct efforts, lead by staff, with the participation from the community, for further studies to investigate the scope of the issue and what other services or actions could be taken by ICANN to support the Universal Acceptance of IDN TLDs beyond outreach and awareness campaigns

#### Recommendation A

- Requirement for IDN TLD operators to support Universal Acceptance of IDN TLDs in their own systems
  - IDN gTLDs and IDN ccTLDs
  - IDN gTLD Accredited Registrars
  - Name servers
  - WHOIS email addresses
    - IDN gTLDs: as requirement
    - IDN ccTLDs: as suggestion

#### Recommendation B

- Allocate specific budget for the advocacy of Universal Acceptance beyond the passive development of informational materials and toolkits
  - Related to Recommendations C & D
  - How will it work in the Budget process?
  - Recommendations to Councils/SGs/Constituencies to be included in their respective comments to budget?

#### Recommendation C

- Development of checklist/guides for new IDN TLDs (including gTLD and ccTLD) to handle issues of Universal Acceptance
  - This is material targeted for new IDN TLDs
  - How should the work be coordinated?
  - How can this be integrated into the work at staff team?
  - How can knowledge from the industry be best leveraged?

#### Recommendation D

- Direct efforts, lead by staff, with the participation from the community, for further studies to investigate the scope of the issue and what other services or actions could be taken by ICANN to support the Universal Acceptance of IDN TLDs beyond outreach and awareness campaigns
  - Scope: e.g. emerging industry standards,
     coordination with other related organizations
  - Additional Services: e.g. known 2LD registries

  - Public Comments: Through Beijing (Apr 2013)
  - Finalization of report: May 2013
  - Presentation to respective councils: Durban (Jul 2013)
- Public Session at ICANN Beijing:
  - a) Discussion of Recommendations
  - b) Inviting additional GNSO (Registries/Registrars especially) and ccNSO members to discuss recommendations

#### Next Steps on Reporting to Councils

- Extension / "Conversion" into standing group
  - Updating "end-date" to: completion of implementation for 3 identified issues of common interest
- Expected work items:
  - Focused on the 3 identified issues of common interest
  - Follow up with respective staff teams
- Revisions on Charter (if any)
  - Formally invite joint charter from ALAC/SSAC?
  - Invitation to GAC?

## **JIG Works Going Forward**

- Monthly Calls (except for ICANN face to face meeting month)
- Face to face meeting at ICANN meetings
- Completion of Universal Acceptance of IDN TLDs Final Report
- Periodically compilation of reports to respective Councils on issues related to IDN TLDs
  - IDN Variant TLD Projects
  - Progress on Single Character IDN TLDs
  - Implementation of recommendations on Universal Acceptance of IDN TLDs
