

Global Issues

- World Telecommunications Policy Forum (WTPF);
- World Summit on Information Society (WSIS)
 Review



WTPF

- •ITU Conference Advisory Nature
- Issue is Internet Governance
- "Opinions" will be adopted
- •Will influence international dialogue



WSIS Review

- !0 year UN Review since 2005 WSIS
- Focus on overall affect of WSIS on global access and connectivity;
- Question whether the multi-stakeholder approach for IG (Adopted in Tunis Agenda) has benefited society
- Does Tunis Agenda need reviewing?
- Should UN /ITU take over management of DNS?

Regional Issues – European Union

Data Protection Regulation

- Directly applicable rules
- Explicit Consent
- Extra-territorial reach

Cybersecurity Strategy

- Completely new legislative approach
- Reporting requirements for breaches
- Mandatory risk based security standards
