Dear Mr. Chehadé:

Pursuant to para. 2.9. of Registry Agreement we herewith notify of our intention to introduce amendments to the Registry-Registrar Agreement, effective as of 18 March 2015.

The purpose of the proposed changes is to ensure compliance with the Registry Operator's obligation per Specification 4 to the Registry Agreement to disclose, make publicly available and de-facto disseminate personal data of private individuals who have become domain names registrants and the requirement of Federal Law of Russian Federation of 27 July 2006 №152-FZ «On personal data» to treat that individual's personal data as confidential ones, i.e. not to disclose those to a third party and disseminate them without consent of the subject of personal data.

The proposed amendments are:

- 1. To include in the languages of sub-para. 6.7.1. of RRA an additional purpose of personal data processing namely, for the purpose of provision of the Whois service;
- 2. To incorporate in Exhibit D Form of Consent to the Processing of Personal Data the private individual's consent to disclosure, making publicly available and dissemination of his/her personal data while providing the Whois service or other similar services, except for where that private individual uses Privacy or Proxy Service.
