We are writing you regarding the 2019 Customer Standing Committee election process slate of members and liaisons. The ICANN Bylaws 17.2.d state that "... the ccNSO and GNSO shall approve each annual slate of members and liaisons being recommended for a new term." The CSC Charter further explains, "while it will not be the role of the ccNSO and GNSO to question the validity of any recommended appointments to the CSC they will take into account the overall composition of the proposed CSC in terms of geographic diversity and skill sets."

The Charter clarifies that "CSC appointments, regardless of whether members or liaisons, will be for a two-year period with the option to renew for up to two additional two-year terms. The intention is to stagger appointments to provide for continuity and knowledge retention.
