Response

1) GNSO

1) Find the template XLS and perform a FILE / SAVE AS. File name should be "GNSO-Council-Motion-Recorder-<Insert Council Meeting Date>.xlsx"
-----GNSO-Council-Motion-Recorder-20180331.xlsx

1) Enter the date of the GNSO Council meeting.

1) This is a free form text field where the primary title of the motion should be recorded.

1) This is a free form text field to record the maker and seconder of the motion.

1) This is a drop-down selection field to record the motion type. It's corresponding threshold is automatically calculated based on the yes/no votes recorded.

1) This date field is automatically filled in based on the date entered on the "Title" tab.

1) The cells containing GNSO Council members allowed to vote are completed based on what is loaded in the "council_members" tab.

2) Update the Council members (usually after the AGM) by their respective house as required.

1) This is a free form text field to record any comments per Council member, record their proxy or alternate assignments, and to record the reason for which a particular Council member chooses to abstain from a vote.

1) Using a "1" in cells F9-I28, record the yes / no / abstain / absent designation.

2) Note that for the calculations to be accurate, all 20 members should be filled out.

3) If there is more than 1 vote recorded for any member, the respective member will be highlighted in RED, or if no vote is recorded, the member will be highlighted in light red.

1) The field defaults to "FAIL" and will only change to "PASS" when the vote threshold has been met based on the respective motion type selected.

1) For "Approval of a petition to remove a director holding seat 13 & 14" or "Approval of a petition notice to remove a director holding seat 13 & 14" these motion types had to be split apart to maintain the threshold logic. **If a house is not required to vote on the removal of another, that house should be recorded as "Abstain".**

1) This section of the sheet is where most of the threshold logic is contained and is meant to provide a credibility check. It will be highlighted in Green when a Motion Type is selected and after the vote is recorded, it will reveal a "1" if the threshold is met. Cell O4 tabulates the threshold result. It will show either a "1" or a "2" to signal that the motion passed and met the respective motion threshold.

1) In general, you want to make all changes to the tab of Motion 1, and then once validated the changes work as designed, the entire sheet can just be copy/pasted across the other motion # tabs to propagate the change.
2) Add the formal motion type name to the drop_down tab. Make sure entries are within the bounds of the Data Validation attribute on cell C4 of Motion 1 tab. Verify that you can see the new motion types available in the drop down menu.

3) Update the rules table on M3:

*** Note that the logic columns of N&O are hidden so they are not printed to PDF. Unhide those, and be sure to hide them again after validation.

- It is best to copy paste/insert of an existing rule that matches the same threshold as the new motion type. This will expedite the update required for the new motion type logic.

- Replace the name of the motion type in cell M(x) with that of the motion type name.

- Update the Conditional Formatting of the same cell M(x) with that of the motion type name.

- Update cell N(x) with that of the motion type name.

- Update the Conditional Formatting on cells C31 & C32 to correspond to each motion type.

*** Remember, in some cases, two rows will have to be used on motions that contain -OR- conditions
