## Multistakeholder Policy Development


The ICANN Policy Development Support Team facilitates bottom-up, consensus-driven processes for global gTLD, ccTLD and IP address policies.



# **Charter for the CCWG on the Use of New gTLD Auction Proceeds**

# What is this about?

1

Auctions are the mechanism of last resort to resolve string contention within the New gTLD Program.

2

Significant funding has accrued as a result of several auctions – currently \$105.6 million USD.

3

Community started discussion on how to deal with funds at ICANN 52. Following a workshop on the topic at ICANN53 a discussion paper was prepared by Staff and Public Consultation opened. Focus on development of framework for disbursement of funds.

4

Following review of public comments on discussion Paper, GNSO Council Chair reached out to all SO/ACs to identify volunteers to participate in a drafting team to develop a charter for a Cross-Community Working Group.

# What to expect at ICANN56

## Overview

- All SO/ACs, apart from the ccNSO, have put forward volunteers (ALAC, ASO, GAC, RSSAC, SSAC);
- Jonathan Robinson appointed by GNSO Council to chair DT;
- DT tasked to develop a charter for a Cross-Community Working Group on new gTLD Auction Proceeds for consideration by the ICANN SO/ACs for adoption;
- First meeting held on 23 February 2016 and meeting regularly thereafter.

## What to Expect at ICANN56

- DT to publish draft Charter for discussion at ICANN56;
- This will be accompanied by:
  - (1) a memo outlining the legal and fiduciary constraints as a result of ICANN's Bylaws and status; and
  - A statement of principles which the DT believes should guide the work of the CCWG.





# New gTLD Subsequent Procedures

## Overview

Community efforts, such as a PDP and various reviews, are underway to take into consideration the 2012 New gTLD round and seek ways to improve, refine, or develop new policy recommendations for new gTLDs, acknowledging that there is existing new gTLD policy from the GNSO's 2007 Final Report on the Introduction of New gTLDs.



# SO/AC Work: GNSO New gTLD Subsequent Procedures PDP

## What is the WG currently working on?

A total of 38 subjects in the WG's charter and 6 have been identified as high-level, overarching subjects. Preliminary discussions have taken place and community input was sought on these subjects.

2

## When will the other 32 subjects be addressed?

WG expects to divide into a series of sub teams to conduct preliminary discussions and again, seek community input.

3

## WG processes

WG will conduct preliminary discussions, seek input from community, integrate work from other efforts, only then reach conclusions.




# **Next Generation gTLD Registration Directory Service (WHOIS) PDP**



# What is this about?

- ⦿ WHOIS started in 1982, when the Internet Engineering Task Force (IETF) published a protocol for a directory service for ARPANET users. Initially, the directory listed contact information requested of anyone transmitting data across the ARPANET.
- ⦿ As the Internet grew, WHOIS began to serve the needs of different stakeholders such as registrants, law enforcement, intellectual property & trademark owners, businesses & individual users - but the protocol remained largely unchanged.
- ⦿ After nearly 15 years of GNSO task forces, working groups, workshops, surveys & studies, the ICANN community has been unable to reach consensus on comprehensive WHOIS policy reforms
- ⦿ In response to the 2012 WHOIS Policy Review Team's Final Report, the ICANN Board launched the RDS PDP & the Expert Working Group (EWG) to inform it, and reconfirmed the request for a PDP in 2014 following the delivery of the EWG Final Report



# What is this about? (continued)



- ⦿ The GNSO RDS PDP WG was formed to attempt to reach consensus on the following questions (*at a minimum*):
- ⦿ **What are the fundamental requirements for gTLD registration data?** When addressing this, the PDP WG should consider, at a minimum, *users and purposes and associated access, accuracy, data element, and privacy requirements*
- ⦿ **Is a new policy framework and next-generation RDS needed to address these requirements?**
  - **If yes, what cross-cutting requirements must any next-generation RDS address,** including *coexistence, compliance, system model, and cost, benefit, and risk analysis requirements*
  - **If no, does the current WHOIS policy framework sufficiently address these requirements?** If not, what revisions are recommended to the current WHOIS policy framework to do so?

# What to expect at ICANN56?

## Overview

This PDP has been tasked with defining the purpose of collecting, maintaining and providing access to gTLD registration data and considering safeguards for protecting that data. This WG is expected to establish consensus requirements for registration directory services, using them to determine if and why a next-generation RDS is needed and then establish a new policy framework to support those requirements.

## What to Expect at ICANN56

The WG is currently gathering available inputs and possible requirements for gTLD registration directory services. This session provides all interested parties with an opportunity to voice their concerns about WHOIS and needs for gTLD registration data, helping to augment and shape the possible requirements to be deliberated upon by this WG.


# How to prepare for ICANN56?

As a foundation for WG deliberations, you are invited to share your input on **possible requirements** in the following areas:

1. **Users/Purposes** – who should have access to gTLD registration data & why (for what purposes)?
2. **Gated access** – what steps should be take to control data access for each user/purpose?
3. **Data accuracy** – what steps should be taken to improve data accuracy?
4. **Data elements** – what data should be collected, stored, disclosed?
5. **Privacy** – what steps are needed to protect data and privacy?
6. **Coexistence** – what steps should be taken to enable next-generation RDS coexistence with and replacement of the legacy WHOIS system?
7. **Compliance** – what steps are needed to enforce these policies?
8. **System model** – what system requirements must be satisfied by any next-generation RDS implementation?
9. **Cost** – what costs will be incurred and how must they be covered?
10. **Benefits** – what benefits will be achieved and how will they be measured?
11. **Risks** – what risks do stakeholders face and how will they be reconciled?
12. **Other Possible Requirements?**



# Global Policy Development

What is a *global* policy?

- ⊙ Global Internet number resource policies “require specific actions or outcomes on the part of IANA.”
- ⊙ All five RIRs must approve the same global policy proposal, which is submitted to the ASO AC for ratification.
- ⊙ ICANN Board may accept, reject, request changes or take no action on a ratified global policy proposal.

Examples

- ⊙ Post-Exhaustion IPv4 Allocation Mechanisms by the IANA (2012)
- ⊙ Allocation of IPv6 Blocks to RIRs (2006)

No global policy proposals exist at this time.

- ⊙ IPv6 allocation policies

# ALAC/At-Large Activities Since ICANN55

- The ALAC responded to the request for feedback from 2 GNSO PDP WGs.
- Other policy activities include holding several capacity building webinars on substantive issues of interest to the At-Large community.

## Advisory on Measurements of the Root Server System (v3)

- Updated RSSAC002v2 with several clarifications based on implementation experience
- The implementation of these measurements helps meet the requirements of RSSAC001 (Advisory on Service Expectations of Root Server Operators)
- Provides valuable data regarding the ongoing expansion of the root zone

# Current Work

## Root Server System Naming Scheme Work Party

- Document the technical history of the names assigned to individual root servers
- Consider changes to the current naming scheme and perform risk analysis
- Make a recommendation to root server operators, root zone management partners and ICANN

## History of the Root Server System

- Chronological history of the root server system from its origin to its current structure, divided into historical periods
- Description the current operators, and their histories in operating the root service, provided by each operator organization
