 - I am very excited to possibly be part of the WHOIS review team at ICANN. I know that the WHOIS has been under review and in discussions at ICANN for quite a few years now, and I was thrilled to see that ICANN is making some progress in the review and development of a new WHOIS policy. I believe that the subject matter and purpose of the review team will combine my passion and desire for creating a better domain name system for all stakeholders with my professional experiences and skills that I have acquired throughout my career.

I would relish to take on the responsibilities to review, advise on, and assist in the implementation of a WHOIS that is mutually acceptable to all stakeholders of ICANN. I am certainly aware that the views diverge widely, but I am confident that we, as a group, can reach a consensus that will appease all groups to a large extent. Of course, no solution will be able to cater to everyone's needs and that, I would submit, is not the goal, but to find an equitable balance among the various views, needs, and desires.

I am currently acting as the Virtual General Counsel at Cognition LLP for various volunteer boards, senior executives, and for-profit boards in a wide range of matters. Throughout my time as the virtual general counsel for my clients, I have developed a reputation for resolving novel and complex problems in an expedient and effective manner that are user-friendly and aligned with the organizations' values and business objectives.

Prior to my engagement with Cognition LLP., I was a member of the senior executive team at the Canadian Internet Registration Authority. During my time at CIRA, I had the great fortune of being part of the development and implementation of the strategic and operations plans, marketing/communications plans, and the management of the general

Further, I was also the project sponsor for most mission-critical projects at the corporation for the duration of my engagement at the Canadian Internet Registration Authority.  - I have been involved in ICANN since 2002 and have been involved in various aspects of the ICANN process. Including presentations to the NCUC ICANN stakeholders on privacy and WHOIS policy changes at the Canadian Internet Registration Authority.
 - Through CIRA, I was also an active participant in the development and creation of the ccNSO and the activities thereafter.
 - While not a GNSO member, I was an Executive Director of CENTR for 2-years.
- A one to two paragraph statement about the applicant's specialized technical or other expertise of direct relevance to the responsibilities of the review team in question.
 - I was, for about 6 years, the General Counsel, Director of Policy Development, and Corporate Secretary of CIRA. As such I was responsible for all the policy, legal, compliance, and governance matters. One of the larger projects I was involved in was the WHOIS reform. This came about due to the adoption of a privacy framework by the Government of Canada (which is based on the EU directive). I led the privacy review of CIRA to ensure compliance with the privacy framework and then implemented the relevant changes necessary to ensure compliance. This included a major overhaul of the WHOIS policy. We engaged in several stakeholder consultations and negotiated with various competing groups (including law enforcement, regulatory bodies, consumer groups, privacy advocates, and commercial groups) to reach a consensus on the final WHOIS policy.

- As a result of our WHOIS activities I presented our findings, conclusions, and final implementation at various fora including CENTR and the NCUC.
