Cost: 150,000 Time estimate: 1 year	<ul style="list-style-type: none"> ▪ Study can count and categorize harmful acts attributed to misuse and show data was probably not obtained from other sources ▪ Some acts might be difficult to count ▪ Difficult to tie WHOIS queries to harmful acts, which makes it difficult to prove that reductions in misuse were caused by specific anti-harvesting measures ▪ Difficult to assess whether misuse is “significant”
2. WHOIS Registrant Identification Study	GAC 5, GAC 6 #13a, #18 GAC 9, GAC 10	1. Gather info about how business/commercial domain registrants are identified. 2. Correlate such identification with use of proxy/privacy services.	RFP approach. 5 responses received. Staff analysis complete to the GNSO Council on 23 March 2010. Cost: 150,000 Time estimate: 1 year	<ul style="list-style-type: none"> ▪ Will classify ownership and purpose of what appear to be commercial domains without clear registrant information, and measure how many of those domains were registered using a Proxy/Privacy service ▪ Might provide insight on why some registrants are not clearly identified ▪ Use of P/P services by businesses
3. WHOIS Proxy and Privacy “Abuse” Study	#17, #19 GAC 1, GAC 11	Compare broad sample of P/P-registered domains associated with abuse with the overall frequency of P/P registrations	RFP was released on 18 May, responses were due by 20 July.	http://www.icann.org/en/announcements/announcement-2-18may10-en.htm Three RFP responses were received. Staff analysis of these responses should be complete by end of August.
4. WHOIS Proxy and Privacy “Reveal” study	#3, #13b, #13c, #20	Study will analyze relay and reveal requests sent for Proxy and Privacy-registered domains to measure associated delays and failures	RFP Terms of Reference are under development. Staff hopes to release RFP in August.
