

**Supplement to Application for Candidacy (AFC) as a New

Dear Rob,

Thanks for the mail and your usual support.

I must clarify that our application is neither any representation for the commercial entities nor commercial in its nature. This proposed constituency would cover intermediaries as well as their internet users. Both the stakeholders are in large number and not covered by any constituency of ICANN so far.

In my opinion, it is not about the existing groups irrespective of Commercial or Non commercial, it is about next level of Internet users and reaching them. They are in billions in emerging economies. Their challenges are completely different to the conventional ISPs and direct users. The shared PC concept/Internet kiosks in emerging economies are very different and have unusual issues on security related concerns.

In case this piece is not visible in our application, kindly insert it there for clarification to the board members. Our review-initial discussion, in my opinion, should be done by the Board. Frankly, it was for the board

to have reached to this constituency but just because of conventions and our initiative, we have applied for the same. Please appreciate that ICANN without this constituency is not representing important stakeholders of Internet ecosystem.
