
SubPro PDP Outputs: Anticipated Board action in Cancun and Dependencies

High-level proposal on how Board/Council/community might move forward on these recommendations

- The Board expects it will approve a large majority of recommendations during its meeting on 16 March 2023; the policy implementation of these recommendations, led by ICANN org and with assistance by the Implementation Review Team (IRT), will start after ICANN76 (Cancun).
- The Board does not plan to consider the recommendations currently marked as 'pending' during its meeting on 16 March, to allow for further discussion. Therefore, the Council would have the opportunity to make amendments to these recommendations and re-submit them for Board consideration, as per PDP Manual.
 - Specifically, the PDP Manual (Section 16) provides the following process for such a scenario: "1. The PDP Team is reconvened or, if disbanded, reformed, and should be consulted with regards to the proposed amendments or modifications; 2. The proposed amendments or modifications are posted for public comment for not less than thirty (30) days; 3. The GNSO Council approves of such amendments or modifications with a Supermajority Vote of both Houses in favour."
 - If desired by the Council, the Board could share amendment proposals that would address its concerns; noting that this would not limit the ability of the GNSO Council and reconvened PDP WG and the GNSO Council to determine and approve the exact wording of any amendments.
- The Council would work with the reconvened PDP WG (per PDP Manual, Section 16 see above) to ensure that proposed amendments are brought oto the Council for a vote no later than ICANN78 (Hamburg) to allow for appropriate time for the Board's consideration and decision no later than ICANN79 (Puerto Rico).
- Any recommendation that has been approved by the Board would be passed on to ICANN org to implement, with assistance by and in consultation with the Implementation Review Team (IRT).
- The Board still has to agree on a path forward regarding the recommendations on PICs/RVCs

Topic 23: Closed Generics	No consensus recommendations from the SubPro Final Report; community dialogue. The lack of consensus on recommendations means that there is no clear path from a policy perspective and there are outstanding questions as to how to proceed with Closed Generic strings	A Board-facilitated dialogue between a small group of individuals selected by the GNSO, GAC, and ALAC have begun to work including a meeting held in late January 2023. Should the dialogue result in an agreed-upon framework, the next step would be for the GNSO Council to move the framework through an appropriate PDP. Should the dialogue not result in a mutually agreed-upon framework, it may be presumed that the Board will need to decide on what the most appropriate action is, within the defined roles and respective remits of the Board, GAC, and GNSO Council.	Prior to completion of Applicant Guidebook. The Board's final action on Closed Generics depends on the outcome of the facilitated dialogue and the results of any additional GNSO policy work. The outcome(s), if any, will need to be factored into SubPro planning, design, and implementation. Note that any action taken by the Board on the outputs is not dependent upon a resolution to the Closed Generics issue.

Topic 17: Applicant Support No consensus recommendations from the SubPro Final Report; The ODA indicates that most SubPro Final Report outputs related to Applicant Support are implementable. Org was unable to determine an appropriate way to fund attorney and consultant fees (Rec 17.2). To inform planning, resourcing, and design, ICANN org is looking to the GNSO Guidance Process (GGP) to articulate what represents success for the Program.	The GNSO Council will deliver to the Board guidance recommendations after its approval of the GGP working group's Final Guidance Recommendations Report anticipated to be in December 2023 or soon thereafter.	Planning and preparation work for Applicant Support can proceed in tandem with the GGP and prior to completion of the Applicant Guidebook. Implementation of the Applicant Support Program (ASP) can start after Cancun, but it cannot be completed before the GGP is completed and its outcome can be included in the final ASP design. The GGP is anticipated to finish its work by December 2023
