## **PPSAI Update & Discussion**

#### Agenda Item #1



Since ICANN78:

- Org took the action to review and identify any areas that may have changed since our last analysis in February 2021. This includes:
  - Developing a **project charter** to scope the policy implementation project, including the resource estimates needed to complete this work.
  - Defining a **path to implement the privacy/proxy recommendations** to leverage:
    - The previous implementation work agreed on with the IRT
    - The current registrar accreditation program
  - Reviewing the recommendations to catalog requirements, updates, and level of effort to implement each.
- ICANN org will conduct another informal session with interested stakeholders at ICANN79 to share and seek feedback on the current thinking and work to date.

#### **PPSAI Update**

- Exploring a method to **implement the policy recommendations** without the need to create and maintain a new accreditation program, and believe this would result in more efficient and faster implementation.
- This path can meet the goals of the policy recommendations while avoiding the development of a separate accreditation program with its own agreement, terms, procedures, fees, enforcement mechanisms, and relationships to manage.
- Using this approach as current working assumption to estimate level of effort across the policy areas.
- This analysis includes items flagged for consultation with IRT and/or GNSO Council.



#### **PPSAI Update**

- Requirements are currently categorized into the following buckets and allocated the expected level of effort for org to define appropriate policy language with IRT.
  - Low is estimated to take roughly 2 weeks; Medium is estimated to take roughly 2 months;
    High is estimated to take roughly 6 months.



#### Next Steps:


- Teams are finalising detailed plans, with support from program management

## **IRT Update**



#### What has happened since ICANN78?

- Discussions around the draft **policy language** for the following topics were initiated with the IRT:
  - Topic 3 | Applications Assessed in Rounds
  - Topic 6 | Registry Service Provider Pre-Evaluation
  - Topic 17 | Applicant Support
  - Topic 19 | Application Queuing
  - Topic 28 | Role of Application Comment
  - Topic 30 | GAC Consensus Advice and GAC Early Warning
  - Topic 31 | Objections
  - Topic 39 | Registry System Testing
  - Root Zone Label Generation Rules module
- Three sub-tracks were launched:
  - Applicant Support Program
  - Registry Service Provider Evaluation
  - <u>Registry System Testing</u>



#### What has happened since ICANN78? (cont'd)

- An initial **Public Comment** proceeding was <u>launched</u> on 1 February 2024 and will stay open through 19 March 2024.
  - Next Public Comment proceedings of draft AGB sections planned for Q3 2023
  - The entire draft AGB will go through a final round of Public Comment prior to the launch of the Next Round.
- Work on the Community Consultation on Public Interest Commitments/Registry Voluntary Commitments (PICs/RVCs) was started, with the objective to ensure that the framework for implementing the relevant Final Report recommendations, adopted by the ICANN Board on <u>26 October 2023</u>, remains consistent with the ICANN Bylaws.
  - A <u>webinar</u> was held on 18 December 2023.
  - The Community Consultation was launched on 21 November 2023.




#### What has happened since ICANN78? (cont'd)

 The Board acted on the GAC Advice on Closed Generics and in a <u>letter dated 22 January 2024</u>, the ICANN Board informed the At-Large Advisory Committee and the Generic Names Supporting Organization Council of its decision that "*closed generic gTLD applications* will not be permitted until such time as there is an approved methodology and criteria to evaluate whether or not a proposed closed domain is in the public interest."


#### **Implementation Plan Overview**

- Updates reflect:
  - The new governance model,
  - The developments with the outstanding dependencies,



### **Registration Data Policy**

Agenda Item #3a





- Implementation preparation: On 21 February 2024 ICANN org published the <u>Registration Data policy</u>. At this time registry operators and registrars continue to implement measures consistent with the Temporary Specification for gTLD Registration Data, and should use this period to *prepare* for implementation of the Policy but not make any changes.
- 2. Implementation Transition Period: Registrars and registry operators may begin to make changes and transition to the Registration Data Policy. At this time registry operators and registrars may continue to implement measures consistent with either the <u>Temporary Specification for gTLD Registration Data</u>, or begin to implement <u>Registration Data Policy</u>, or elements of both.
- 3. Registration Data Policy is Effective. Registrars and registry operators must *comply in full* with the Registration Data Policy (Interim Policy sunsets, e.g., Stage 3). At this time implementation must be completed.



# **Rights Protection Mechanisms (RPM) Phase**

Agenda Item #3b



Since ICANN78:

- The <u>Public Comment</u> period on the proposed changes to the RPM-related procedural documents, which were revised in accordance with the relevant PDP Phase 1 outputs, closed on 30 October 2023. (Group 1 recommendations)
- The IRT is in the process of reviewing the public comments to consider whether any further changes need to be made as a result of the input received. (Group 1 recommendations)
- The IRT has also started working on the recommendations concerning the development of educational materials to assist users of the RPMs. (Group 2 recommendations)

#### **RPM Implementation Estimated Timeline**

	Milestone	Estimated Timing
1	Complete implementation of recommendations in Group 1 (i.e. publish revised RPM procedural documents) - a total of 14 recommendations	By end of March 2024
2	Complete implementation of recommendations in Groups 2 & 3 (i.e. publish RPM-related educational materials and update URS contact data) - a total of 5 recommendations	By end of April 2024
3	Implement recommendations in Group 4 (collect RPM-related data) - a total of 1 recommendation	May – September 2024
4	Implement recommendations in Group 5 (develop new URS compliance mechanism) - a total of 1 recommendation	October – December 2024

\* Note: Regarding the remaining recommendations from the RPM PDP, a total of 9 recommendations called for maintaining the status quo (i.e. the current rules as applied to the gTLDs delegated under the 2012 New gTLD Program application round) and a total of 5 recommendations called for specific changes to the Applicant Guidebook and/or the Base Registry Agreement for subsequent rounds of new gTLDs, which are being implemented as part of Work Track 1 of the Subsequent Procedures IRT.

#### **IGO Curative Rights Policy Recommendations**

- **Project Charter**: In development to implement the GNSO's Consensus Policy recommendations on Curative Rights.
- **Project Scope**: The five recommendations from the IGO Specific Curative Rights Protections EPDP (2022) & four recommendations from the IGO-INGO Access to Curative Rights PDP (2019).
- **Project Team**: ICANN org will work on the implementation in consultation with an Implementation Review Team (IRT).
  - To streamline implementation, ICANN org proposing IRT as a small, expert set of community members with experience in the UDRP, URS and online arbitration processes.
- **Project Deliverables**: Specific deliverables are expected to include publication of revised URS/UDRP documentation and policy guidance documents.
