

## STANDING COMMITTEE ON CONTINUOUS IMPROVEMENTS (SCCI) – WORK ASSIGNMENT OVERVIEW

<b>Subject Background</b>	<b>CONTINUOUS IMPROVEMENT PROGRAM (CIP) FRAMEWORK CRITERIA AND INDICATORS (PARTS 1 &amp; 2)</b> <p>The GNSO Standing Committee on Continuous Improvement (hereafter “SCCI”) is convened by the GNSO Council (hereafter “Council”) as a permanent committee to allow for execution of continuous improvement related projects that are focused on the GNSO’s structural, procedural, and process improvements to the Policy Development Process (PDP)<sup>2</sup>. Notably, this work affects the GNSO community more broadly and not limited to that of the Council. For avoidance of doubt, all assignments of the SCCI and Task Forces (TFs) shall be first approved by the Council. Each SCCI or TF project assignment will, at minimum, use the small team assignment <a href="#">form</a>, task force assignment <a href="#">form</a>, or full <a href="#">charter</a> that will be determined in the initial scope phase of the assignment.</p>
<b>Assignment</b>	<ul style="list-style-type: none"> <li>- Starting with the existing draft Criteria from CCOICI, formulate the Criteria and Indicators (i.e., CIP Framework) for GNSO.</li> </ul>
<b>Timing</b>	Small Team to share findings and recommendations by <b>October 2025</b>
