

Next Steps for SSAD Recs

SC's Rationale for Rec. 5 (Non-adoption)

- Ultimate goal is to “**achieve a functional policy** that adapts to the changed circumstances and **benefits from the lessons learned** of the RDRS pilot”.
- “Acknowledges that many of the EPDP Phase 2 recommendations were conceived and adopted by the GNSO Council as a **comprehensive and interdependent package**.”
- The SC “report and the previous ODA report **provide justification for rejecting the SSAD recommendations**”
- “**Language in the SSAD report** indicating the intent to treat the SSAD recommendations as a single package.”


Additional Considerations



SC recommends improvements to **all 18 recommendations**



No practical advantage to adopting a subsection of recs
since implementation will not begin until SSAD is approved



Familiar and previously successful approach from SubPro
(Small Team Plus → suppl. recs.)



Next Steps for SSAD Recs

What is non-adoption? (ICANN Bylaws, Annex A, Sec. 9) Process

-  1. Board has concerns with GNSO policy recommendations (not in best interest of ICANN) (A(9)(a))
-  2. Board **explains reasons for discomfort in a written statement** and provides to Council (A(9)(b))
-  3. **Opportunity for dialogue** b/w Board and Council (A(9)(c))
-  4. Council has **opportunity to discuss and develop** (via small team, for example) **Supp. Recs.** (A(9)(d))
-  5. **Council votes** on supplemental recommendations (when completed) (A(9)(d))
-  6. Council sends supplemental recommendations to Board (A(9)(d))
-  7. **Board votes** (A(9)(d))



Why a dialogue?

[Resolved \(2023.02.27.08\)](#), the ICANN Board directs the Interim President and CEO, or her designee(s), to publish usage statistics concerning the System on a regular cadence once the System becomes operational. These usage statistics will inform periodic check-in discussions with the GNSO Council. The Board expects that no later than two years after the System goes into operation, the Board and GNSO Council shall re-initiate discussions concerning the next steps on the GNSO Policy Recommendations concerning the System for Standardized Access/Disclosure.”
